Additional information on billing by PVS bayern GmbH (PVS), Arnulfstr. 31, 80636 Munich

PVS will bill for medical/therapeutic services, issue invoices, and collect fees from you. PVS is an independent company that is part of the PVS holding GmbH group of companies, which is also its parent company. PVS works together with its parent company, PVS rhein-ruhr GmbH, and PVS berlin-brandenburg-hamburg GmbH & Co. KG (sister companies). The parent company handles accounting on behalf of PVS, provides the IT infrastructure, including maintenance and support, and handles printing and mailing. PVS rhein-ruhr GmbH maintains the service center for patient and customer communication and, like PVS berlin brandenburg-hamburg GmbH & Co. KG, can take over the recording of services for invoicing on behalf of PVS and handle correspondence necessary for the collection of fees. PVS is available to you as the data controller responsible for data processing in this context to protect your rights and answer any questions you may have. The employees of the aforementioned companies are bound by professional secrecy and are therefore subject to professional confidentiality and data protection regulations, as prescribed for doctors. PVS issues the invoice in its own name, collects the fee claim, and is available to you as a contact partner. Until final payment has been made, PVS is also subject to the instructions of the service provider, who remains in charge of the procedure, with regard to the amount of the fee claim. By signing, you consent to the assignment of the fee claim and to the processing of data for the purposes of invoicing, debt collection, and evaluation of the medical work. Your personal treatment data, such as your address, date of birth, cost bearer, any tariffs, treatment days, services provided according to the fee schedule, and associated diagnoses will be transmitted to the above-mentioned PVS companies for this purpose. The treatment is, of course, not dependent on this consent. You can also exclude individual treatments from this declaration. In this case, the service provider would have to carry out the billing themselves. This will not result in any disadvantages for you. You can revoke your consent at any time with effect for the future. Data processing carried out up to the time of revocation remains lawful. Your data may then continue to be processed to the extent required by law. The revocation can be made to the service provider or PVS by means of a written declaration stating your name and address (invoice number, if applicable). This will not result in any disadvantages for you either.
